# **NOT TRAINING - SYSTEMATIC HARASSMENT**

No one has ever been resprayed in Alaska. The one individual (and individual's shift) that is chosen to be the first person to be resprayed is Officer McLellan. Below are some examples where ACOA asked State Officials to stop the harassment and abuse of Officer McLellan over the last 5 years.

## 1. November 6, 2013 Letter

- > Sent to: Captain Hans Brinke, Alaska State Troopers
- These Officers were singled out to be assaulted in order to further punish and victimize one Officer, their former Shift Sergeant, Officer Randy McLellan...this latest escalation of abuse, this latest bullying, is a crime."

- ➤ "The Grievant, Sergeant Randy McLellan, who is the President of the Alaska Correctional Officers Association, has been systematically and unjustly harassed and persecuted by the Department of Corrections (DOC) for having spoken out on health and safety issues of major concern to the Correctional Officers he represents."

- "Randy is again being harassed and falsely accused."

- I cannot begin to convey the disappointment we all feel in the treatment of Sergeant Randy McLellan and the extraordinary scrutiny he has come under since speaking up on behalf of the Association. The harassment, from the Commissioner calling him a liar in the press for his **truthful** statements to the many investigations that followed, is uncalled for."

- ➤ "After being defamed by the Commissioner openly, Sergeant McLellan has been investigated again and again. This must stop... It is not just wrong because this is America, not just wrong because government should not be used as a hammer against its citizens, but it is wrong because government officials, appointed by the Governor, should display some respect for basic fairness."

#### 11. November 25, 2009 E-mail

- Sgt. McLellan's treatment (and his shift) would definitely be a topic of importance."

# 12. March 6, 2009 Letter

- > Sent to: Commissioner Kreitzer, Commissioner Schmidt, Deputy Director Sheehan, Director Brandenburg
- ➤ "Due to Sergeant McLellan speaking up on ACOA matters, he has come under attack, including the Commissioner of Corrections mentioning him by name on the Eddie Burke show (4/24/08). Not only has he been harassed by investigations, but when those

investigations failed to "get him", they went after him through his shift members by force-transferring them to other shifts."
