

# ACOA Twelve Gun Giveaway

## 2021 Complete Rules

**1. Eligibility:** Due to COVID-19, this year's Raffle is open **only** to current or former Alaska Correctional Officers. Open only to legal residents of a State in the United States where residents are legally permitted to enter in a raffle and who are age 21 years or older at time of entry. Subject to all applicable Federal & State & local laws & regulations. Void where prohibited by law.

**2. Agreement to Rules:** By participating in the Raffle, you agree to be fully and unconditionally bound by these Rules, and you represent and pledge (declare or guarantee) that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of ACOA, as final and binding regarding the content.

**3. Raffle Period:** Entries will be accepted starting on or about January 6, 2021 until December 1, 2021.

**4. How to Enter:** The Raffle must be entered by purchasing a raffle ticket. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Raffle tickets that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of ACOA. Alaska Correctional Officers or former Alaska Correctional Officers may purchase as many tickets as each would like. All information must be filled out completely on each raffle ticket purchased. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of ACOA. You may purchase tickets by calling ACOA at 907-646-2262 or by going to the ACOA website and clicking on [www.acoa.us/twelve-gun-giveaway/tickets/](http://www.acoa.us/twelve-gun-giveaway/tickets/). Please note that per state gaming regulations, the option to purchase tickets online is open to only those physically present in Alaska. After you purchase one or more tickets, ACOA will mail you the ticket. If you call to purchase a ticket, please be sure to give us your mailing address and phone number so we can correctly fill out the ticket(s) and get them to you.

**5. Standard Prizes:** If your raffle ticket is drawn you are eligible to select from the remaining of the following prizes: SAKO TRG 22 in 6.5 Creedmoor caliber (\$2,750), Henry .45-70 Brass Wildlife Edition (\$1,350), Browning Citori 725 Over/Under shotgun (\$2,595), Kimber Super Carry Pro (\$1,395), Kimber Mountain Ascent (\$2,650), Sturm, Ruger, & Co. Inc. Model AR-556 SKU # 8500 (\$1,348), Beretta A-400 Xcel MultiTarget w/kickoff (\$2,650), Springfield Armory M1A: "Loaded" M1A with walnut stock - SKU #MA9222 (\$1,769), Kimber Camp-Guard, 10mm caliber, 1911 semi-auto pistol (\$1,069), Winchester Model 70 Feather Weight, stainless steel, with Dark Maple stock (\$1,400), Sturm, Ruger, & Co. Inc. Model: Super Redhawk "Toklat" (\$1,249), Sturm, Ruger & Co. Inc. Model AR-556 SKU # 8529 (\$1,358), Alaska Airlines tickets (\$800), Ring Home Surveillance Package (\$846.99), DJI MAVIC Air Quadcopter UAV (\$988), and OCULUS RIFT + Touch Virtual Reality System (up to \$800 value).

The actual/appraised value may differ at the time of prize award. The specifics of the prize shall be solely determined by ACOA. No cash or other prize substitution is permitted, except at ACOA's discretion. All prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the winner. No substitution of prize, transfer/assignment of prize to others, or request for

the cash equivalent by winners is generally permitted. ACOA may, at its sole discretion, choose to provide the cash equivalent of the winner's chosen gun to the winner instead of the gun itself. Reasons for this variation of standard practice may be, but are not limited to, the individual fails to pass a background check, is underage, or for any other reason as determined by ACOA.

**6. Odds:** The odds of winning depend on the number of eligible raffle tickets purchased. There are 3000 raffle tickets total and there are 12 total drawings in which each purchaser is automatically entered (12 monthly drawings).

**7. Winner selection and notification:** Winners of the Raffle will be selected on the first Wednesday of each month in a random drawing under ACOA's supervision, except that all the drawings yet to be conducted on December 1, 2021 will all be drawn on that date to satisfy 15 AAC 160.650(e). Winners will be notified via phone at the phone number the winner entered on the raffle ticket within five (5) days following each drawing. ACOA shall have no liability for a winner's failure to receive notices due to the winner's provision of incorrect or otherwise non-functioning contact information. You do not have to be present at any of the drawings to win.

The receipt of the prize offered in this Raffle is conditioned upon compliance with all federal and state laws and regulations. Any violation of these official rules by any winner (at ACOA's sole discretion) will result in such winner's disqualification as winner of the Raffle and all privileges as winner will be immediately terminated.

**8. Shipping and Gun Registration:** Every winner who selects a gun as his or her prize must complete a background check and meet his or her State's individual requirement for purchasing a firearm. If that individual fails to meet these qualifications, they will be required to select from the remaining of the four (4) non-gun prizes. If those prizes are no longer available, then ACOA will pay the purchase value of the selected gun (the amount for which ACOA purchased the gun) to the winner. If the winner is located in, or around, Anchorage he or she is required to come to Great Northern Guns at 4425 Wright St, Anchorage, AK 99507, to complete the background check and pick up the gun chosen. If the winner lives out of the Anchorage Bowl, there is an option for the gun to be shipped to a federally licensed and registered gun retail outlet, as required by State and Federal law, near them, where a background check will be conducted prior to the winner being given the gun. Additionally, by participating in this raffle, all winners agree to hold ACOA harmless in the event the weapon causes injury or death.

**9. Rights Granted by you:** By entering this contest, you understand that ACOA, anyone acting on behalf of ACOA, or its respective licensees, successors and assignees will have the right, where permitted by law, without any further notice, review or consent, to print, publish, broadcast, distribute, and use, worldwide, in any media now known or hereafter in perpetuity and throughout the world, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image, or statements about the Raffle, and biographical information as news, publicity, or information, and for trade, advertising, public relations and promotional purposes without any further compensation.

**10. Terms:** ACOA reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Raffle should (in its sole discretion) a virus, bug, non-authorized human intervention, fraud or other cause beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Raffle. In such case, ACOA may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action which impacted the integrity of the Raffle. ACOA reserves the right, at its sole

discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Raffle, or who violates these Terms & Conditions.

**11. Limitation of Liability:** By entering you agree to release and hold harmless ACOA and its representatives, agents, assignees, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Raffle and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) unauthorized human intervention in any part of the entry process or the Raffle; (iii) electronic or human error which may occur in the administration of the Raffle or the processing of entries.

**12. Disputes:** THIS RAFFLE IS GOVERNED BY THE LAWS OF THE UNITED STATES OF AMERICA AND ALASKA, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Raffle, participant agrees that all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Raffle, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Alaska having jurisdiction. Further, in any such dispute, under no circumstances will participants be permitted to obtain awards for, and hereby waive all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Raffle), and participant further waives all rights to have damages multiplied or increased.

**13. Privacy Policy:** All non-winner information submitted with an entry is private, but per State law must be held for a period of three (3) years. All tickets and information will be destroyed upon completion of this three (3) year period of the Raffle with the exception that winners' information may be distributed at the sole discretion of ACOA.
